ABBREVIATIONS ARE REFERENCED FROM THE CONSTRUCTION SPECIFICATION INSTITUTE'S UNIFORM DRAWING SYSTEM TERMS AND ABBREVIATIONS MODULE.

CONTRACTOR MUST VERIFY IN FIELD ALL EXISTING CONDITIONS AND DIMENSIONS PRIOR TO COMMENCING WORK. CONTRACTOR MUST NOTIFY THE ARCHITECT OF ANY DISCREPANCIES BETWEEN EXISTING CONDITIONS AND THE CONTRACT DOCUMENTS PRIOR TO COMMENCING WORK.

DRAWINGS DO NOT SCALE AND MUST NOT BE SCALED. USE GIVEN DIMENSIONS ONLY. DETAILS GOVERN OVER PLANS, ELEVATIONS & SECTIONS; LARGE SCALE DETAILS GOVERN OVER SMALL SCALE DETAILS. NOTIFY ARCHITECT OF ANY DISCREPANCIES AND/OR CONFLICTS PRIOR TO COMMENCING WORK.

COORDINATE ALL WORK WITH OWNER'S ENVIRONMENTAL REPORT. LIMIT AND SCOPE OF HAZARDOUS MATERIAL REMEDIATION IS NOT DEFINED IN CONTRACT DOCUMENTS. ANY AND ALL WORK RELATED TO HAZARDOUS MATERIALS IS EXPLICITLY EXCLUDED FROM ARCHITECTURAL SCOPE.

ALL DIMENSIONS ARE TO FINISHED FACE/SURFACE UNLESS NOTED OTHERWISE.

CONTRACTOR MUST PAY FOR AND OBTAIN ALL LEGALLY-REQUIRED PERMITS BEFORE COMMENCING WORK, AND MUST OBTAIN ALL LEGALLY-REQUIRED APPROVALS UPON COMPLETION.

CONTRACTOR MUST CARRY ALL LEGALLY-REQUIRED INSURANCES AND MUST SUBMIT EVIDENCE OF SAME.

THE WORK OF ALL TRADES MUST BE COORDINATED BY THE CONTRACTOR.

ALL WORK MUST BE PERFORMED BY SKILLED AND PROPERLY-QUALIFIED TRADESPEOPLE AND MUST BE CARRIED OUT IN ACCORDANCE WITH THE HIGHEST TRADE STANDARDS AND INDUSTRY BEST-PRACTICES AND ALL GOVERNING LAWS, REGULATIONS & STANDARDS.

ALL MATERIALS, COMPONENTS, EQUIPMENT ETC. MUST BE INSTALLED IN ACCORDANCE WITH THE MANUFACTURER'S INSTRUCTIONS.

CONTRACTOR MUST PROTECT AND SECURE THE SITE AND ALL WORK AGAINST DAMAGE, FIRE, THEFT, VANDALISM, AND ALL OTHER DETRIMENTAL CIRCUMSTANCES FOR THE ENTIRE DURATION OF THE PROJECT.

CONTRACTOR MUST KEEP SITE CLEAN AND FREE OF DEBRIS AT ALL TIMES.

CONTRACTOR MUST FACILITATE ACCESS FOR THE OWNER AND CONSULTANTS TO VIEW THE WORK AS REQUESTED.

CONTRACTOR MUST COMPLY WITH ALL LOCAL, STATE, AND FEDERAL LAWS, CODES, AND OTHER REQUIREMENTS GOVERNING WORK PERFORMED AND THE MANNER IN WHICH WORK IS PERFORMED.

CONTRACTOR MUST PROTECT ALL EXISTING PROPERTY ADJACENT TO THE WORK FROM DAMAGE CAUSED BY ANY ACTIVITY RELATING TO PERFORMANCE OF THE WORK. CONTRACTOR MUST REINSTATE ANY DAMAGE CAUSED TO SUCH PROPERTY AT CONTRACTOR'S OWN EXPENSE.

CONTRACTOR MUST AT ALL TIMES MAINTAIN A CURRENT HARD-COPY SET OF THE CONTRACT DOCUMENTS (INCLUDING ALL CHANGE ORDERS, SUPPLEMENTAL INSTRUCTIONS, CONSTRUCTION CHANGE DIRECTIVES, AND OTHER CONTRACT MODIFICATIONS) ON SITE AND IN A LOCATION THAT CAN BE VIEWED BY THE OWNER, CONSULTANT TEAM, AUTHORITY HAVING JURISDICTION, AND ALL OTHER RELEVANT PARTIES. PRIOR TO COMMENCING ANY PORTION OF THE WORK, CONTRACTOR MUST CONFIRM THAT THE PROPOSED WORK CONFORMS WITH THE REQUIREMENTS OF THE MOST CURRENT DOCUMENTS.

ALL WORK RELATED TO THE STAGING, CONSTRUCTION PRACTICES, AND SAFETY OF ALL ASPECTS OF THE PROJECT SHALL BE CONSIDERED MEANS AND METHODS OF CONSTRUCTION AND SHALL BE COMPLETED BY THE CONTRACTOR IN ACCORDANCE WITH STANDARD INDUSTRY PRACTICES AND ALL APPLICABLE CODES, STANDARDS, LEGISLATION, AND REGULATIONS. MEANS AND METHODS ARE EXPLICITLY EXCLUDED FROM THE CONTRACT DOCUMENTS. VISITS TO THE SITE MADE BY THE ARCHITECT AND CONSULTANTS ARE FOR OBSERVATION OF THE WORK FOR GENERAL PERFORMANCE WITH THE DRAWINGS AND SPECIFICATIONS AND EXPLICITLY EXCLUDE REVIEW OF CONTRACTOR RESPONSIBILITIES, INCLUDING BUT NOT LIMITED TO PROJECT SAFETY AND MEANS AND METHODS OF CONSTRUCTION. CONSTRUCTION OBSERVATION CARRIED OUT BY THE ARCHITECT AND CONSULTANTS EXPLICITLY MUST NOT BE CONSIDERED AS AN INSPECTION, AND EXPLICITLY MUST NOT BE CONSIDERED AS CONSTRUCTION SUPERVISION OR MANAGEMENT IN ANY FORM.

CONTRACTOR SHALL MAINTAIN EMERGENCY VEHICLE ACCESS TO THE CONSTRUCTION SITE AT ALL TIMES. SNOW, MUD, DEBRIS, UNSUITABLE DRIVING SURFACES, LOCKED GATES, AND OTHER OBSTRUCTIONS SHALL NOT BE ALLOWED TO INTERFERE WITH ACCESS TO THE SITE.

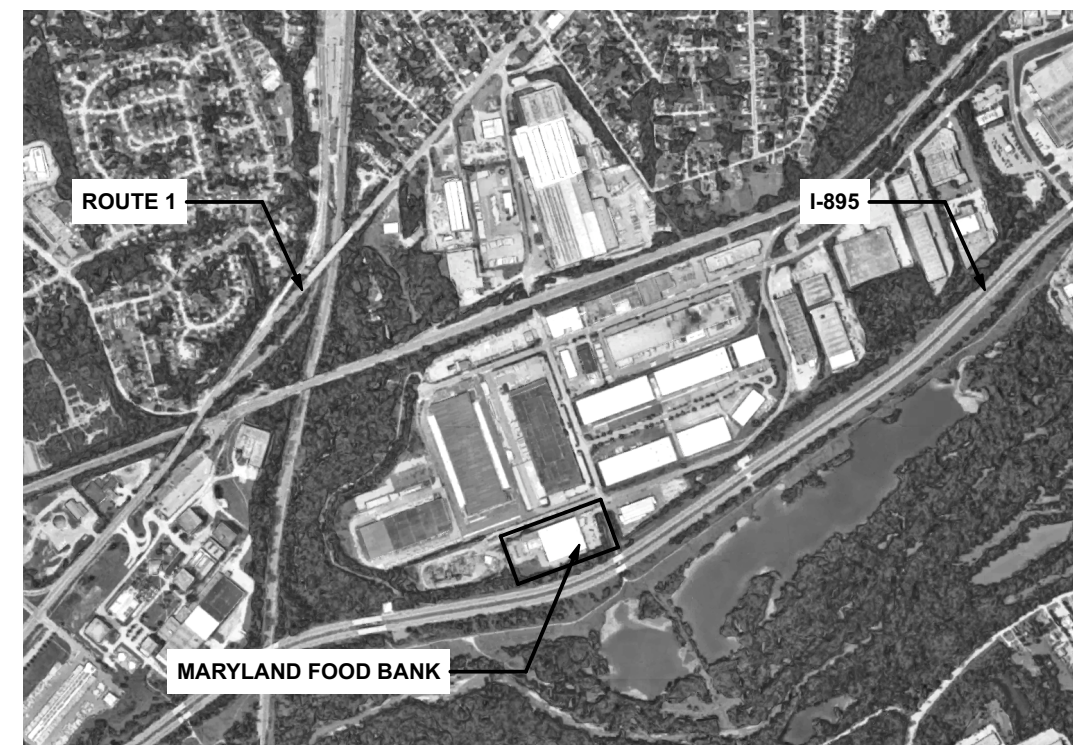

CONTRACTOR SHALL MAINTAIN SECURITY LIGHTING IN THE AREA OF CONSTRUCTION SO THAT THERE IS ADEQUATE LIGHTING IN ALL PEDESTRIAN AND PARKING AREAS ADJACENT TO THE CONSTRUCTION SITE.

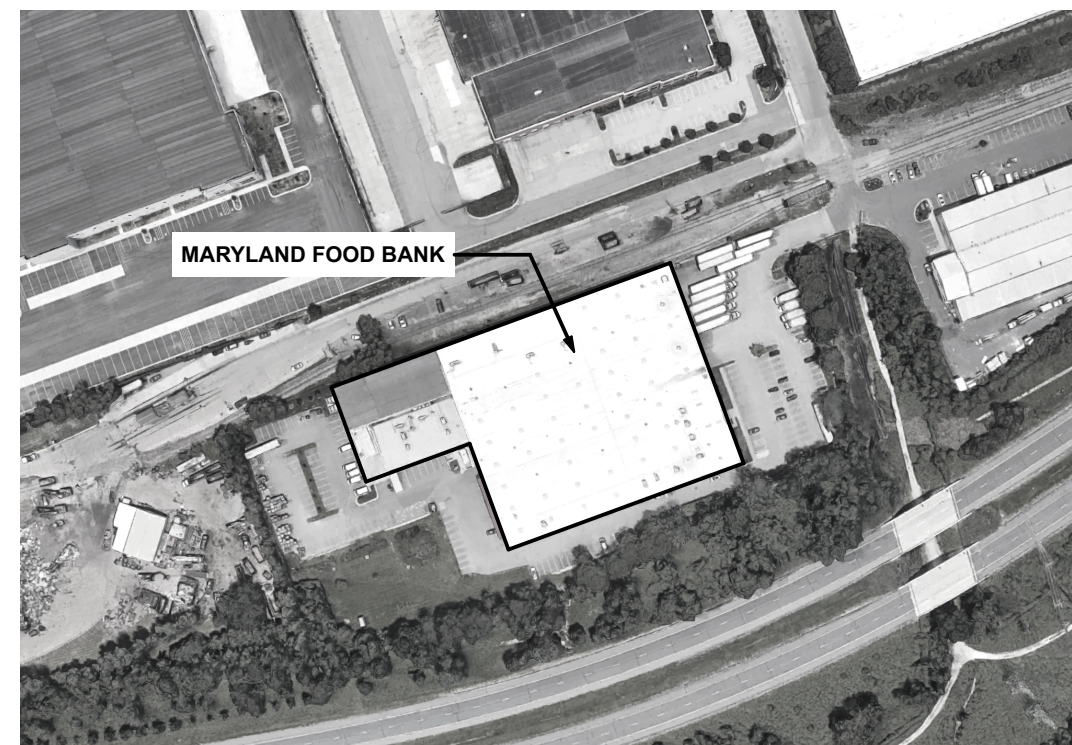

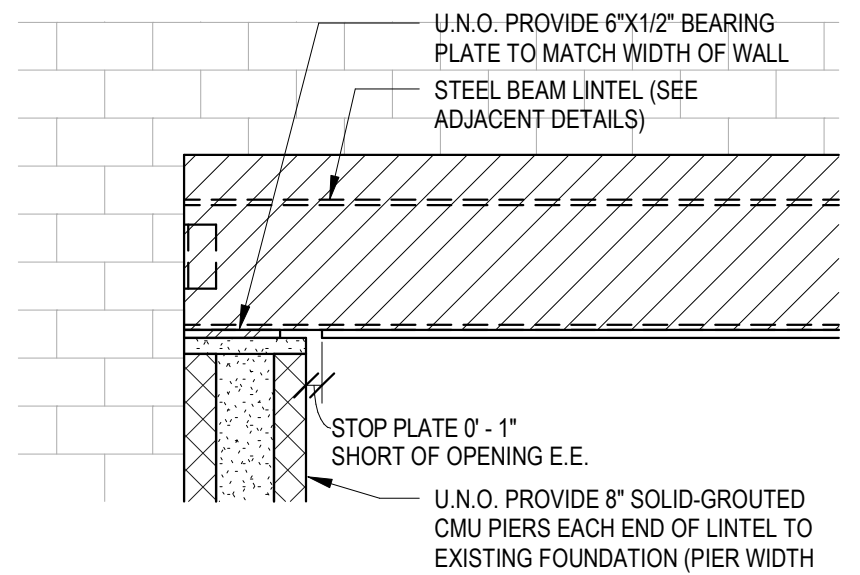
